Rationale:

Teaching and learning are the core functions of St. Anne's C.E. Lydgate Primary School. We believe that effective teaching is the provision of high quality experiences designed to ensure that children have opportunities to learn in a stimulating and supportive environment.

Aims:

- 1. To help children reach their full potential in terms of their intellectual, creative, moral and spiritual development.
- 2. To teach children to be tolerant, sensitive and understanding showing respect for the rights, view and property of others.
- 3. To develop in children a responsible attitude towards their work and towards their roles in society.
- 4. To develop in children an independence and enjoyment of learning.
- To encourage children to engage in learning in a positive way, reflecting on their effort and progress so enabling them to approach challenging tasks with confidence and resilience.
- 6. To raise standards for all.

At St. Anne's we believe that the quality of teaching is a crucial factor in promoting effective learning in school. Good quality teaching has many attributes and the most important ones are outlined below:

We believe that a teacher achieves positive results if he/she:

- is well planned and prepared;
- maintains good control and ensures children are on task;
- has high expectations of work, attitude and behaviour;
- makes lessons interesting and challenging;
- has good subject knowledge;
- uses a variety of appropriate teaching strategies (individual, group, whole class etc.);
- has well established classroom routines:

- maintains pace and rigor;
- has a good understanding of the needs of individuals, groups and classes;
- demonstrates good questioning skills;
- uses resources efficiently and effectively;
- provides feedback in relation to planned objectives and the quality of work produced in accordance with the school policy and practice;
- enjoys positive relationships with children and
- employs effective time management both before, during and after class sessions.

Effective organisation and classroom management is vital and a range of teaching styles can be employed. Teachers have both the right and responsibility to develop a climate in the classroom, which supports effective learning without compromising their personal qualities and professional skills.

At St. Anne's we believe that quality learning develops from effective teaching.

Quality learning is recognised by how children:

- show enjoyment and involvement in their learning;
- ask and answer questions and actively join in discussion;
- maintain sustained concentration whilst listening and during tasks;
- respond to challenge, persevere and complete tasks when difficulties arise;
- develop their capacity for independent work, learn from their mistakes, improve on their work and take a pride in the finished product;
- generate ideas and solve problems;
- apply knowledge and understanding to new work;
- behave, in terms of their respect for others, their responsibility to others and themselves and the degree to which they are courteous and trustworthy;
- work together;
- show respect for others' feelings values and beliefs, and
- show initiative and are willing to take responsibility.

Equal Opportunities

St Anne's CE Lydgate Primary School is an inclusive school where we focus on the well-being and progress of every child and where all members of our community are of equal worth.

We believe that the Equality Act provides a framework to support our commitment to valuing diversity, tackling discrimination, promoting equality and fostering good

relationships between people. It also ensures that we continue to tackle issues of disadvantage and underachievement of different groups.

The Equality Act 2010 was introduced to ensure protection from discrimination, harassment and victimisation on the grounds of specific characteristics (referred to as protective characteristics). This means that schools cannot discriminate against children/staff or treat them less favourably because of their gender, race, disability, religion or belief, gender reassignment, sexual orientation, pregnancy or maternity. Age and marriage and civil partnerships are also "protected characteristics."

The formulation of this policy is in line with the Equality Act.

Monitoring and Evaluation

Policy and practice is regularly evaluated. Feedback along with recommendations to inform future policy and planning with be given to all relevant parties.

The school leadership team have a responsibility to ensure the policy is embedded into the school provision and report to governors on the effectiveness of the policy at least every 3 years.
